

Minutes of the Meeting of the Board of Trustees

November 12, 2019

Board Members Present: Danal Abrams, Laura Blankfein, Adam Falkner, Laurence Heilbronn, Randall

Board joined by Sara Corona, Elisa Murphy, teacher Christian Morehouse, and PA representative Ellie.....

The Meeting was brought to order by Chair, Danal Abrams, at 6:10 and a quorum was found present.

- Trustee Falkner moved for approval of minutes from July 2019 meeting; seconded by trustee Heilbron. Minutes approved unanimously by voice vote.
- Chair Abrams presented the (attached) recitals and resolutions to the full board (1) to raise the fixed number of board members from 7 to 8 and (2) to elect Max Osse for a seat on the board. Seconded by trustee Murphy and carried by unanimous voice vote.
- Chair Abrams gave a brief overview of current financials. School continues to remain in the overall budget as established earlier in the year. Finance committee is to look at a revised budget in the next month based on FTE of 276 rather than 278.
- Proposals under review for consultation on preparing and writing the renewal application. Presentation of alternatives and final selection to be made at December general meeting.
- School Leadership Team Report
- Discussion about possibility of using shared DOE elevators is going forward with other schools in the building.
 - Enrollment steady at about 276
 - Gleaning issues that may affect future enrollment from departing families' reasons. These include length of school day; late start; competition from other schools recruitment; shift to homeschool due to immunization or student anxiety.
 - Continue to hold open houses and information sessions
 - Two students returned to CSA from transfers
 - Already hosting school tours for next year.

Attendance

- Committee on Chronic Absence tracking students with excessive absences
- Encouragaing positive rewards for perfect attendance dress-down days, awards, mention at assemblies
- Academic/Instructional shifts
 - Math Teacher/School Culture employee quit abruptly likely sub to be retired teacher from Newark school during transition to new full-time teacher
 - Head-of-school holding individual meetings with all teachers to understand needs and concerns better as step to improve staff retention



- Staff has daily "huddle" to start the day along with daily calendar of events
- Arts integration project includes Theater for a New Audience partnership –
 presenting "Twelfth Night" along with Manhattan Youth (after school program)
- Member Murphy mentioned strength of science teaching from her school tour
- Strong science program in part due to partnership with Teachers' College
- School Culture/Discipline
 - Initiating a Dean's List
 - Tracking infractions and interventions
 - More careful definition of "defiance" and new interventions led to decrease in reports of this behavior
 - Ten students previously on list of most infractions have moved off it
 - New emphasis on early intervention lunch sessions with dean, mentoring, parents "shadowing" students
 - School Leadership made presentation at most recent Family Association meeting to hear from parents/guardians and to dispel rumors about overly strict rules or inconsistent enforcement of school norms. Parent Ellie ... commented that it was a good start and that the manner or approach to how discipline is maintained is as important as the norms themselves
- Proposed community-based fundraiser concert by Dr K to be more fully developed for final consideration.
- Election of Officers postponed to December general meeting.
